



DROP IN REGISTRATION POLICY

The Kamloops Pickleball Club welcomes visitors and guests who would like to play at any of the club's venues.

Visitors and guests to the Kamloops Pickleball Club indoor and outdoor venues are required to pay a \$10.00 drop in registration fee and to **complete and sign** the DROP IN registration form below. This \$10.00 drop-in fee will entitle the guest to 3 drop-in visits to a Kamloops pickleball venue. If the visitor or guest would like to become a member of the Kamloops Pickleball Club, this \$10.00 will be credited to the yearly membership dues.

Please note that many of our indoor and outdoor pickleball venues have a per play venue fee and this venue fee is in addition to the drop-in fee paid. For example, TRU has a per play venue fee of \$5.00, this fee is in addition to the drop in visit included in your drop in registration.

The opener for the venue will take the guest's registration form and \$10.00 payment and will provide the guest with the tear off receipt at the bottom of the form. It is the responsibility of the guest to retain this receipt as proof of payment of their drop in registration. The opener for the venue will also initial the receipt each time the guest drops in at a venue. There is a maximum of 3 drop in visits permitted under this policy. If the guest wishes to continue to play at Kamloops Pickleball Club venues after their 3rd visit they will be required to purchase a yearly membership.

As a Kamloops Pickleball Club member, if you are bringing a first time visitor we encourage you to bring a filled out form along with exact payment to help speed up the initial signup process.

-I give permission for Kamloops Pickleball Club (KPC) to use/distribute without limitation or obligation, any record (voice or image) of the events in which I participate-attend.

-I agree to allow KPC to communicate with me by email regarding events, news, sales, etc.

RELEASE and WAIVER of LIABILITY

-You, the Player, are aware that there are risks associated with participating in pickleball activities and exercise. Your participation is completely voluntary, and you freely accept and fully assume all responsibility for all risks, and all possibilities of personal injury, dear, property damage or loss to yourself or any other person as a result of your participation in pickleball activities.

-You waive all claims, known and unknown, that you have or may have in the future against the Kamloops Pickleball Society, including the directors, coaches, instructors, volunteers and other members of the Society.

-To release and forever discharge the Kamloops Pickleball Society from all liability for any personal injury, death, property damage of loss resulting from your participation in pickleball activities due to any cause, including but not limited to negligence (failure to use such care as a reasonably prudent and careful person would use under similar circumstances), breach of any imposed bylaw, breach of contract or mistake in error of judgement of the Kamloops Pickleball Society.

-To be liable for and to hold harmless and indemnify the Kamloops Pickleball Society from all actions, proceedings, claim, damages, costs demands, including court costs of a solicitor and own client basis, and liabilities of whatsoever nature or kind arising out of or in any way connected with your participation in pickleball activities.
